**S.O. 1145(E).**— In exercise of the powers conferred under sub-section (3) of section 25 and clauses (a) to (d) of sub-section (2) of section 4 of the Khadi and Village Industries Commission Act, 1956 (61 of 1956), read with rules 3 and 4 of the Khadi and Village Industries Commission Rules, 1957, and consequent upon dissolution of the existing Khadi and Village Industries Commission under Notification No. S.O. 1120 (E) dated 14<sup>th</sup> October, 2004, the Central Government hereby re-establishes the Commission and appoints the following persons as members of the Khadi and Village Industries Commission, namely:-
